<p><b>PLANNING COMMISSION (5 members)</b> Conducts hearings and renders decisions on applications for various permits required by City's zoning ordinance. Conducts hearings for investigation and review of amendments to the City's General Plan. Report findings &amp; recommendations to City Council. Investigates, review &amp; report findings/recommendations to City Council on the design and improvements of proposed major subdivisions, and creation of any proposed redevelopment area within the City. Conduct design review proceedings for commercial and multi-family residential projects.
