The Project would develop 145 residential units (135 one-bedroom, 10 two-bedroom) in a six-story building of modular construction, and 43 surface parking spaces (6 on street) on a 1.04-acre site, All units would be affordable at the low income level. Approvals include major design review, use permit due to proximity to San Pablo Creek, and density bonus with concessions and a waiver. Additional density and height granted due to location in a very low travel area.
