



CITY OF SAN PABLO TWO-YEAR (BIENNIAL) FISCAL YEAR 2025 – 2026 GENERAL FUND OPERATING & CIP BUDGET ADOPTION PROCESS

ADOPTED BUDGET PROCESS AND PUBLIC MEETINGS

The City of San Pablo has successfully completed its Fiscal Year (FY) 2025 – 2026 Two-year (Biennial) GF Operating and Capital Improvement Program (CIP) Budget development, and adoption process. The budget adoption process concluded on May 20, 2024 with formal City Council adoption by enabling Resolution #2024-064, and becomes **effective July 1, 2024**. The City wishes to thank all community members who submitted their input and suggestions on the City's budget priorities via the on-line budget survey, and in person at scheduled public meetings

The City's newly, adopted two-year budget plan focuses on elimination of \$5M in forecasted deficits for the FY 2025 – 2026 period, financial sustainability, and maintains existing City service delivery that are most valued by our local San Pablo residents and businesses. Major budget balancing measures adopted include: freezing six (6) existing FTE employee vacancies; implementing a City-wide 5% reduction in City Department spending; reducing Police Department overtime expenses by 25% due to full-staffing levels, and applying a total of \$5M over the next two (2) fiscal year periods from available FY 2023-24 year-end audited fund balance, and a one-time appropriation of \$377,000 from the City's Budget Stabilization Fund.

PAST BUDGET MEETINGS

City Council Long Range Financial Forecast Plan (LRFFP), New City Financial Condition, and Strategic Budget Initiatives Adopted for FY 2025 – 2027 Period

Held on Wednesday, December 13, 2023

In September 2023, the City Council commissioned a new Long-Range Financial Forecast Plan (LRFFP) which reviews all current and past City expenditures and revenue trends from FY 2023-24 (base year) over the next 10-year budget cycle. As a result of this new LRFFP, the City is facing a new financial condition as of December 13, 2023, and the City Council adopted new Strategic Budget Initiatives to provide measures to address and eliminate forecasted operating deficits in the coming years. WHAT IS A CITY GENERAL FUND (GF) BUDGET?

The City's GF budget is an annual or multi-year financial planning tool that matches the City's programs and services desired by the community to the budgetary resources available to deliver such programs and services, including but not limited to: police, recreation, senior services, fire protection and emergency services, community development, public works, and administrative services. San Pablo's GF Budget provides critical resources needed to provide the longevity and sustainability of City service delivery that the community desires and needs over the next 3-year period.

PREVIOUS FY 2022-23 & 2023-2024 TWO-YEAR (BIENNIAL) ADOPTED GF BUDGET
