

REUSABLE BAG SUPPLIERS

The San Pablo Single-Use Carryout Bag Ordinance defines a “Recycled Paper Bag” as a paper bag that (1) contains no old growth fiber, (2) is a 100% recyclable and contains a minimum of 40% postconsumer recycled material, (3) displays the words "Reusable and Recyclable" in a highly visible manner outside of the bag, (5) displays the percentage of postconsumer recyclable material used, and (6) the name and location of the manufacturer.
