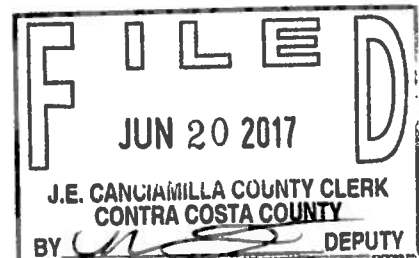
Description of Project: The Agreement between the City of San Pablo and Capital Partners Development Company, LLC provides for the sale by the City and the Purchase and redevelopment by Capital Partners of that certain property located at Plaza San Pablo, Blocks F&G, Lot 6, (APN 417-310-005). The Agreement is exempt from environmental review under CEQA 15061(b)(2), 15061(b)(3), 15312, 15316, 15325E, and 15331 of the CEQA guidelines. The Agreement enables Capital Partners to design and construct a new city hall on that property. The parcel is 2.50 acres, and the New City Hall includes a two story, 42,000 sq.ft. building on currently vacant land, in a Priority Development Area. It has been determined that the project would be consistent with the assumptions for the project site as presented in the City's General Plan and the San Pablo Avenue Specific Plan, and the project would not result in any new significant impacts identified in the General Plan Environmental Impact Report (EIR), San Pablo Avenue Specific Plan Environmental Impact Report, or the Mixed Use Center South Mitigated Negative Declaration (MND). The City Council approved the Agreement and design and construction on June, 19, 2017, by Resolution 2017-126.

Name of Public Agency Approving Project: City of San Pablo

This is to advise that the City of San Pablo, as Lead Agency, has approved the above described project on June 19, 2017 and has made the following determinations regarding the above described project.

Determination: Pursuant to the California Environmental Quality Act (CEQA) Section 15162, and 15183(a), no additional environmental analysis is required. An environmental conformance document was completed and adopted as part of the adopted Resolution approving the project. It was concluded that the project would be consistent with the assumptions for the project site as presented in the City's General Plan, San Pablo Avenue Specific Plan, and the Mixed Use Center South Regulating Code. It also was concluded that the project would not result in any new significant impacts or increase the severity of any significant impacts identified in the City's General Plan EIR, San Pablo Avenue Specific Plan EIR, or the Mixed Use Center South MND. The circumstances under which the project would be undertaken have not substantially changed such that new or more severe impacts would occur. Therefore, no further environmental analysis is required.


1. The project will not have a significant effect on the environment.
