


PUBLIC SAFETY ACHIEVEMENT

- Greatly Reduced by 12.3% in City-wide Part 1 Crimes: 1,926 (Jan. – Nov. 2016) vs. 1,683 (Jan. – Nov. 2017)
- Reduced Number of Homicides: 2 (2016) to 1 (2017)
- Hired a total of eight (8) New Police Officers and Non-Sworn Personnel combined
- Appointed Ron Raman as the 9th Chief of Police in the City's History. Chief Raman is the 1st Fiji born Chief of Police in the USA.
- Adopted new Policy on Comprehensive Immigration Reform and Federal Immigration Enforcement for City's PD (March 2017)
- Implemented enhanced police surveillance cameras and shot spotter technology
- Received \$100k grant from ABC for enforcement, training, and education for alcohol establishments throughout the city (June 2017)
- Enhanced Police Surveillance Cameras to include construction of pole tower atop Police Department and the implementation of ALPR Vigilant software
